RE: Northwest Jeffco and South County Library Naming Discussion

Naming Background

The naming process for our new South County and Northwest Jeffco Libraries has been progressing thoughtfully and deliberately since July, following the steps laid out in our inaugural Library naming process.

After extensive brainstorming with our internal naming teams, JCPL staff, as well as stakeholders from the Northwest Jeffco and South County communities, were invited to participate in a naming feedback survey. The in-depth responses received through the survey, along with a structured criteria ranking and evaluation process, guided our team in developing a shortlist of recommended names that were presented to the Chief Executive Team (CXO) in September.

The CXO discussion provided further naming insights and guidance on potential names which, combined with an initial review by the County Attorney's Office to confirm naming availability, resulted in the final names that will be presented to the Board tonight.

Next Steps

The list presented for Board discussion this evening reflects extensive community and historical research, as well as feedback and insights from staff, leadership, community members and Jefferson County's legal team. Staff will incorporate tonight's Board feedback before bringing this item back to the Board for final naming selection.
