- Collective bargaining negotiations continue
- JCPL & AFSCME have spent more than 128 hours at the bargaining table
- 25 of 28 total articles have been addressed or are in negotiation, representing approximately 89% of the total contract (as of 10/27)





- An asbestos spill occurred in the Administration wing on Oct. 2 during restroom reconstruction
- The contractor continues to work with required regulatory agencies and certified experts to comply with legal requirements, testing and abatement
- Administration is currently closed until this work is completed
